

9th European Workshop on Advanced Control and Diagnosis 2011

17-18 November 2011 Budapest, Hungary



According to the IEEE CSS Outreach fund proposal submitted on May 18, 2011 the total funding requested was USD 12,500, which was approved on 22 July, 2011. The requested budget can be divided into three main groups:

- Accommodation and registration fees of the four distinguished plenary speakers.
- Subsidizing registration fees, with special emphasis on Developing Country participants and students.
- Room rental and conference equipment, including video recording of the plenary talks.

The conference organization was handled by SCOPE Ltd company, from which SZTAKI received the invoices about the various cost components. "Final_Invoice.pdf" attached to the report details the list of cost components, including 3 Meeting rooms + wifi for 2 days (4440 EUR); laptops, projectors, video (1125 EUR); and Plenary speakers' accommodation (738 EUR).

Based on the recommendation of the reviewers, 60 papers were finally accepted. These papers were presented in 9 sessions based on 3 parallel tracks. Among the 157 authors of the 60 accepted papers, about 78 delegates from 19 different countries attended the workshop during these 2 days, representing a wide variety of countries, as shown in Table 1.




Figure 1. Authors' Countries Involved in the ACD2011 Workshop

38 registered attendants came from developing countries, who were selected based on the criteria of the International Monetary Fund's list of developing economies, representing 11 different nations. Table 2. details the list of countries and the amount claimed to be paid by the Outreach Fund, which includes the full registration of the four plenary speakers. Another document "Signatures_full.pdf" lists all the registered participants with their signatures. The total amount related to subsidizing registration fees requested from the Outreach Fund is EUR 4400 (USD 5741).
